Welcome to The Bolivar 53 in the heart of the Mississippi Delta! The property features mature timber with flood control structures in place. Hunt deer in the fall and transition to ducks as the winter rains approach. The Mississippi Delta is known for BIG whitetails and this property is no different. The 53.04± acre tract is located just 3 miles from the Mississippi River Levee and adjoins the north side of Dahomey National Wildlife Refuge. The access is by deeded easement setting the owner up for pure seclusion and low-pressure hunting. The property has crop ground on the three sides meaning you won't need to spend a penny on summer deer plots. There is one wildlife plot in place and the back road can be planted as well. On dry years, water can be pumped from a neighbor's well if expense arrangements are made. Get ready for Mississippi Delta timber hunting!
